Cooperative's 86th Annual Meeting

THE COOPERATIVE'S 86TH ANNUAL MEETING will be held Wednesday, April 9, at the Bedford County Fairgrounds, 729 W. Pitt St., just west of downtown Bedford on Business Route 30. The fairgrounds are next to the Bedford Exit of Interstate 99. Once again, by popular request, we are hosting a "drive-thru" meeting.

Finding a parking spot will not be a concern at this event, which begins at 10 a.m. and ends at 1:30 p.m. (**Note:** Please do not arrive before 10 a.m. to avoid traffic backing up on to Route 30.) At any point during those hours, while remaining

in your car, members will enter the main entrance of the fairgrounds and follow the marked route. At stops along the way, members will register, pick up an annual report and receive a ballot to vote in the election of directors (if you haven't already voted by mail). Members may also enjoy free refreshments, pick up an attendance gift and turn in their completed ballot if voting at the meeting. Registered attendees will also be eligible to win door prizes. Lucky winners will be announced after the meeting.

We want to make voting as convenient as possible for our members, so we offer a variety of ways for you to participate. Around March 15, you will receive a packet in the mail. It will contain the official notice of the meeting, your registration card for the meeting and a mail-in ballot. Once the packet is received, it is up to you to decide if you want to vote by using the mail-in ballot or bringing your registration card to the meeting and voting in person. *Members cannot do both.* If you choose to vote by mail, your ballot must be received by our election vendor **before April 5**, so please allow sufficient time for postal delivery. Also, if you vote by mail, we still encourage you to attend the meeting.

Each year, the annual meeting is a defining moment for all cooperatives across the United States. Why? Because it presents the opportunity for voting members to democratically control the future of their cooperative. Each member has an equal voice in choosing their member-representatives on the board of directors. What better way to map the future of the organization than by helping to decide who sits on our nine-member board?

Our directors are community-minded individuals with a range of backgrounds and skills. We rely on them to help us make informed decisions on long-term priorities and investments. All nine directors live in the co-op's service area, and we consider them the eyes and ears of the community because they each provide unique perspectives on local issues.

Directors are elected for three-year terms, with three of the nine seats up for election each year. Five members were interested in being on this year's ballot. The following pages contain profiles of the candidates vying for the three director seats. Each was selected by the Nominating Committee. This year, we did not receive any petitions from members asking to be added to the ballot, and no additional nominations will be accepted at the annual meeting.

DISTRICT 3: Dale R. Sprigg II



OUTAGE REPORTING

In case of an outage...

Check your fuses or circuit breakers.

Check with your neighbors, if convenient, to see if they have been affected by the power failure.

Call the 24-hour number, 814-623-7568, OR call 800-808-2732* during office hours.

*(Please help us save money – only use this number if toll charges apply.)

Please give the person receiving the call your name as it appears on your bill, your telephone number and your map number, if known. Any specific information about the outage will also be helpful in pinpointing the problem.

During widespread power outages, many memers are calling to report power failures. You may receive a busy signal, or in certain cases, your call may go unanswered. This occurs in after hours outages when the office is not fully staffed. Please be patient and try again in a few minutes.
