## ELECTRIC APPLIANCE REBATE PROGRAM 2025-2026 TERMS and CONDITIONS

Bedford Rural Electric Cooperative, Inc (BREC) members may be eligible to receive a rebate, in the form of a bill credit, for installing qualifying Energy Star rated appliances. Verify your appliance by visiting [www.energystar.gov](http://www.energystar.gov) (then go to "Product Finder").

### Program Procedures & Requirements:

- Qualifying appliances must be certified as Energy Star to be eligible. Verify your appliance by visiting [www.energystar.gov](http://www.energystar.gov) (then go to "Product Finder")
- Limited to one rebate per appliance type per (12) month period.
- Appliance must be installed within BREC's service territory.
- Members are responsible for proper disposal of pre-owned appliances.
- After all program requirements are met, a rebate in the form of a bill credit will be issued to the member's account.
- All applications must be complete and include a **payment receipt**.
- All projects must comply with applicable federal, state, and local laws and building codes.

### Installation Verification:

Bedford Rural Electric Cooperative, Inc reserves the right to inspect the member's home for installation of materials listed on the rebate application & to verify the installation meets program guidelines. The member may not receive the rebate if BREC cannot verify the information provided on the application form.
